

# **HSE Policy Statement Veco Precision Metal**

Concern for the health and safety of our employees and concern for the Environment (HSE) is an essential part of the policy and operations within Veco Precision Metal. Our HSE policy is aimed at controlling the HSE risks, with the objective to continually reduce the foreseeable risks that can lead to personal injury, damage to health and welfare, property damage and to negative effects for local residents and on the environment.

The scope of the HSE policy contains all Veco activities at Eerbeek, The Netherlands, including Sales, Purchase, R&D, Engineering, Production, Quality Assurance & Control, Logistics and the maintenance of installations and machinery.

Veco ensures an optimal working environment for employees and minimizes negative environmental impacts resulting from production, products and/or services.

### Principles in this context are:

### <u>1. The HSE risks must be controlled.</u>

Veco requires HSE hazard identification through risk assessment, monitoring of critical measures, and preparation of the emergency organization, in order to reduce adverse effects such as incidents and accidents, absenteeism, occupational diseases and environmental damage.

2. Business continuity and flexibility is facilitated.

Veco strives for an open and proactive relationship with stakeholders (employees, shareholders, local residents and businesses, government and environmental groups).

HSE standards implemented will allow headroom for business development.

### 3. Veco wants to meet (internal and external) HSE laws and regulations.

Veco wants guaranteed compliance with laws and regulations that apply to us.

4. The HSE performance is continually improved.

Veco wants the HSE risks and the environmental impact of our business operations to continually decrease.

5. The organization promotes a proactive HSE culture.

Veco wants to actively involve alle employees in the identification of HSE hazards, the assessment of risks, the assurance that critical measures are in place and the deployment of the emergency response organisation, so that a proactive HSE culture is experienced at all levels in the company.

# In the implementation of the HSE policy, the following principles are leading:

1. HSE hazards are validated.

The hazards are defined on the basis of facts: scientifically based studies, measurements and/or calculations. Risks are mitigated to acceptable levels. Risks are reduced or controlled at their source as much as possible. Specifically for the control of risks of major environmental accidents involving dangerous substances Veco Precision Metal developed a Major Accident Prevention Policy (MAPP). The critical measures to avoid major accidents must be guaranteed.

### 2. Management commitment

HSE is seen as a pillar of our business. Veco frequently evaluates its HSE policy objectives, its HSE improvement objectives, and its HSE performance and if necessary Veco will amend them. Veco strives for a responsible balance between social interests, environmental and financial returns (people, planet, profit). Senior Management integrates HSE in all business decisions. Consultation and participation of workers is arranged through the Works Council.

### 3. Organizational integration

First-line Management is responsible for HSE performance. The line therefore signals, initiates and carries out. The HSE department has a supporting and consulting role, and helps management to continuously improve through the exertion of a Plan–Do–Check–Act (PDCA) cycle.

# 4. Knowledge development

Veco recognizes that HSE management needs specialist knowledge. Where necessary external knowledge will be utilised, e.g. on laws and regulations, measurements, risk models, etc. The HSE department has the task of transferring this knowledge to management and the organization.

# 5. Management System

In order to achieve its HSE objectives, management is supported by an HSE management system. The management evaluates the effectiveness of the HSE policy and management system at regular intervals, and guarantees the adequacy of resources for maintaining it. The HSE management system covers:

- Monitoring changes in internal and external issues that can impact HSE management, such as
  risks and opportunities, needs and expectations of relevant interested parties and legal and
  other requirements.
- Arranging relevant communications with internal and external interested parties.
- Monitoring and measuring HSE performance and emissions to the environment.
- Responding to and learning from incidents and non-conformities.

# 6. Internal and external audits

Veco will determine whether the HSE system is suitable and securely implemented through frequent internal and external audits. For these audits the international standards ISO 14001 and ISO 45001 are leading.

## 7. Support systems

For the HSE management system to function adequately the company makes use of fit-forpurpose support systems.

Concern for health, safety and environment is the responsibility of every employee working for Veco. This requires a full commitment from both management and employees. All employees must be aware of the HSE policy, familiar with the risks of their activities to their health and to the environment, and adhere to the HSE requirements and regulations in the performance of their duties. This also applies to external workers carrying out activities within the establishment.

The responsible managers are expected to actively disseminate this HSE policy within the organization and, in accordance with this policy, supervise sound HSE performance at work.
